Call for Session Proposals

The MLTSS Leadership Summit, hosted by the National MLTSS Health Plan Association, brings together leaders from across the healthcare spectrum and provides engaging conversations about solutions to the biggest challenges facing managed long-term services and supports (MLTSS) today.

This exclusive, invitation-only event serves as a collaborative platform for government officials, heads of health plans, and MLTSS providers to present and debate key issues.

The MLTSS Association is seeking proposals for sessions held on **September 25 and 26, 2024** for the 2024 MLTSS Leadership Summit held in Washington, D.C., at [101 Constitution](#).

Proposal Guidelines

The overall intent of our sessions is to elevate best practices, spotlight common barriers, ideate on policy trends and opportunities, and encourage innovative solutions through shared learning and thought leadership.

We encourage proposals that not only highlight innovation but also help identify gaps or areas for improvement in MLTSS care and payment.

Session Specifics:

- **Length:** Limited to 60 minutes in maximum length.
- **Session Format:** Could be one of several types, including panel discussion, single presenter, fireside chat, roundtable discussion, or spark round. Please indicate the type of session you are most comfortable participating in.
- **Speakers:** Each proposal may consist of a maximum of three speakers representing different organizations. Similar proposals may be grouped together to create more comprehensive panel sessions. The MLTSS Association reserves the right to pair organizations with similar proposals to enrich panel discussions.
- **Materials:** You are welcome to use slides but are encouraged to incorporate interactive and participatory approaches. Special preference will be given to those who offer an avenue for interactivity.

Note: Proposals that solely promote vendors' products or services will not be considered.

However, we welcome proposals that **highlight new data, innovation, and collaboration among plans, providers, and/or states.**

Topics of Interest

We especially encourage proposals that align with our topics of interest listed below (with a non-exhaustive list of example areas for each topic).

- **Value-Based Contracting:** *Best practices, quality measurement, data collection and analysis, plan and provider collaboration, contract requirements*
- **Strengthening the Direct Care Workforce:** *Recruitment, retention, data collection and evaluation, workforce alternatives, elevating the value of direct care workers*
- **Integrated Care for Dually Eligible Beneficiaries:** *Enrollment, stakeholder education and awareness, state capacity, care coordination, shared savings opportunities, SMAC efforts, Medicare-Medicaid Plan transitions, data sharing.*
- **Improving Equity & Addressing Health-Related Social Needs:** *Unique financing mechanisms, intersection between health-related social needs and functional limitations, new contract requirements*
- **MLTSS System Innovation:** *New technologies, rebalancing efforts, person-centered care planning*

Proposal Instructions & Guidelines

Submissions must include:

- Presentation title and description (400-word limit)
- Three learning outcomes, takeaways, or action items for the audience
- Session format and description of how your session will promote dialogue and engagement (200-word limit)
- Speaker(s) names, organizations, headshots, and bios
- Optional: accommodations or other needs for the session (500-word limit)

Submissions should be compiled into a single Word or PDF document and emailed to info@mltsssummit.org with a subject line of MLTSS Summit Session Submission.

Please note: Travel and lodging expenses are the responsibility of the presenter. Your registration costs will be waived with the acceptance of your proposal. Some meals are included with registration.

Proposal will be reviewed and accepted on a rolling basis up until April 30, 2024. We encourage you to submit as early as possible.
